

## **End-User License Agreement (EULA) of Travonto**

This End-User License Agreement ("EULA") is a legal agreement between you and Travonto

This EULA agreement governs your acquisition and use of our Travonto software ("Software") directly from Travonto or indirectly through a Travonto authorized reseller or distributor (a "Reseller").

Please read this EULA agreement carefully before completing the installation process and using the Travonto software. It provides a license to use the Travonto software and contains warranty information and liability disclaimers.

If you register for a free trial of the Travonto software, this EULA agreement will also govern that trial. By clicking "accept" or installing and/or using the Travonto software, you are confirming your acceptance of the Software and agreeing to become bound by the terms of this EULA agreement.

If you are entering into this EULA agreement on behalf of a company or other legal entity, you represent that you have the authority to bind such entity and its affiliates to these terms and conditions. If you do not have such authority or if you do not agree with the terms and conditions of this EULA agreement, do not install or use the Software, and you must not accept this EULA agreement.

This EULA agreement shall apply only to the Software supplied by Travonto herewith regardless of whether other software is referred to or described herein. The terms also apply to any Travonto updates, supplements, Internet-based services, and support services for the Software, unless other terms accompany those items on delivery. If so, those terms apply. This EULA was created by EULA Template for Travonto.

### **License Grant**

Travonto hereby grants you a personal, non-transferable, non-exclusive licence to use the Travonto software on your devices in accordance with the terms of this EULA agreement.

You are permitted to load the Travonto software (for example a PC, laptop, mobile or tablet) under your control. You are responsible for ensuring your device meets the minimum requirements of the Travonto software.

You are not permitted to:

- Edit, alter, modify, adapt, translate or otherwise change the whole or any part of the Software nor permit the whole or any part of the Software to be combined with or become incorporated in any other software, nor decompile, disassemble or reverse engineer the Software or attempt to do any such things
- Reproduce, copy, distribute, resell or otherwise use the Software for any commercial purpose
- Allow any third party to use the Software on behalf of or for the benefit of any third party
- Use the Software in any way which breaches any applicable local, national or international law
- use the Software for any purpose that Travonto considers is a breach of this EULA agreement

## Intellectual Property and Ownership

Travonto shall at all times retain ownership of the Software as originally downloaded by you and all subsequent downloads of the Software by you. The Software (and the copyright, and other intellectual property rights of whatever nature in the Software, including any modifications made thereto) are and shall remain the property of Travonto.

Travonto reserves the right to grant licences to use the Software to third parties.

## Content & Media

Travonto is treated as Social Network, which means all the content in it is user-generated content either by customers, or by members of Travonto team. There is no tolerance for objectionable content or abusive users. All users that will be guilty of racism, sexism, or any other type of abuse - will be banned from the platform.

Travonto does not take any responsibility for the content being posted on the platform. If you feel that any laws are breached, please report this and we will take immediate action to address the case.

## Termination

This EULA agreement is effective from the date you first use the Software and shall continue until terminated. You may terminate it at any time upon written notice to Travonto.

It will also terminate immediately if you fail to comply with any term of this EULA agreement. Upon such termination, the licenses granted by this EULA agreement will immediately terminate and you agree to stop all access and use of the Software. The provisions that by their nature continue and survive will survive any termination of this EULA agreement.

## Governing Law

This EULA agreement, and any dispute arising out of or in connection with this EULA agreement, shall be governed by and construed in accordance with the laws of GB.
